2016 Day Camp Program Refund Policy

No refunds except for medical reasons accompanied by a doctor's medical note.

In the event that your child enrolls in camp and withdraws because of homesickness or is asked to leave because of misconduct, there will be **no refund**.

Camper Dismissal: A camper whose behavior is disruptive to the camp program or harmful to himself/herself, others, or the property of camp or others, will be dismissed at the discretion of Camp Director, with **no refund of fee**.

2016 Day Camp Policies**1. No Personal Items/Electronic Devices**

Campers are NOT permitted to bring any personal items from home. This often increases the likelihood of them getting lost, stolen or damaged. Cell phones are NOT permitted at camp. The camp staff reserves the right to confiscate any and all personal items as issues arise. Confiscated items will be returned to the parent at the end of the day.

2. Late Pick-up

Participants that are picked up from camp after closing are subject to late fees. Fees are as follows: 15-30 minutes: \$7.50; 30-60 minutes - \$15.00. Late fees shall be collected at the time of pick up and are per child. Child protective services may be notified if campers remain more than an hour without contact from the parent. Habitual tardiness could result in dismissal from the program.

3. Snacks/Lunch

A morning snack consisting of a nut free, wheat free, milk free bar/muffin and 1 piece of fruit (apple, banana, pear, orange) will be provided by Farrington’s Music. **FULL DAY CAMP:** For lunch, campers are required to bring a non-perishable menu(easy to open and store container) that is ready to eat and does not require heating, and a drink(in a reusable bottle).
